The IGA, which has been prepared by the County Attorney's Office, will be forwarded to your grant administrator (four original copies) along with an ACH funds transfer form. As soon as your governing body and/or authorized official has approved, signed and returned the four (4) copies of the IGA and the ACH form to Daniel Einarsen, grants administrator for Arapahoe County's Open Space Program, the Grant IGA will be forwarded to County officials for final execution, and, upon completion, funds will be disbursed per the terms of the IGA. Grant funds must be spent on this project in the manner described in your grant proposal, project budget and timeline, as well as in accordance with Arapahoe County Open Space Resolution No. 030381 and the grant IGA. In order to comply with the IGA, a grant status report is also due to the County grants administrator, no later than January 31, 2011. Subsequent status reports will be required as per the IGA, along with full accounting, including the original budget compared to actuals, of funds expended. Please send to Daniel Einarsen, Arapahoe County Open Space, 10730 E Briarwood Ave, Suite 180, Centennial, CO 80112. The report shall include a description of progress, milestones, and use of grant funds to date. The IGA also requires the Grantee's acknowledgement of Arapahoe County as Grantor and the County sales and use tax as a source of funding, in your publications, new releases, and permanent signage at the project site.

We look forward to seeing how your project will improve the quality of living in your community, as well as for all citizens of Arapahoe County. We thank the voters for supporting the Open Space Program, and for the benefits this program provides to your community
